This Exhibitor Space contract is subject to the terms and conditions set forth below. This form must be completed to confirm your booth reservation.

Exhibitor Space Assignments: The California Small Business Success Conferences reserves the right to rearrange or alter the floor plan, as necessary in its sole option, or as required by law and the Pasadena Conference Center.

Subletting of Space: Exhibitor agrees not to assign or sublet the space assigned to it without the express written consent of the California Small Business Success Conferences. The exhibitor agrees to sell and/or display only the products or services listed and approved by the California Small Business Success Conferences in this contract.

Product/Services Offered by Exhibitor: The Exhibitor agrees not to claim or represent, either orally or in writing, that any product or service offered at or during the conference is endorsed or approved by the California Small Business Success Conferences. All food related samples or giveaways must be pre approved by CSBSC prior to the event.

Exhibitor Booths: The exhibitor agrees to set up his/her booth only during the times and hours specified and allowed by the California Small Business Success Conferences. Booths shall be completely set up prior to the conference opening and the exhibitor shall maintain competent personnel to staff the booth during the advertised conference hours. The booths shall not be dismantled or altered during the entire conference without the express written permission of the California Small Business Success Conferences. The exhibitor agrees to promptly dismantle and remove from the premises the entirety of the display and all its component parts, as soon as possible after the final closing of the conference to the public, and no later than the final posted tear down and move out time. The exhibitor shall return the premises to its original condition at the conclusion of the conference or the termination of this contract.
